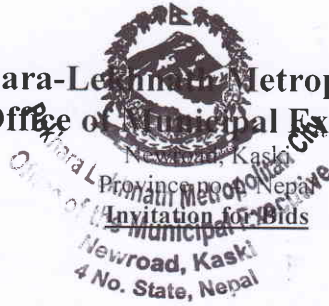

1. Pokhara-Lekhnath Metropolitan city, Office of Municipal Executive, Newroad Pokhara has allocated funds for following Projects. Bidding is open to all eligible Nepalese Bidders.
2. Pokhara-Lekhnath Metropolitan city, Office of Municipal Executive, Newroad Pokhara invites sealed bids or electronic bids from eligible bidders for the construction of **following Project** under National Competitive Bidding procedures. Only eligible bidders **as per clause 40(2) of PPR 2064** should participate in this bidding.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the Pokhara-Lekhnath Metropolitan city, Office of Municipal Executive, Newroad Pokhara [Telephone: 061-521105, Fax: 061-520600 , email:pokharalekhnathmun@gmail.com] or may visit PPMO website www.bolpatra.gov.np.

A complete set of Bidding Documents may be purchased from the office Pokhara-Lekhnath Metropolitan city, Office of Municipal Executive, Newroad Pokhara by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **amount 3000.00** till **5th Feb-2018 (2074/10/22) within office hour**.
Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Sealed or electronic bids must be submitted to the office Pokhara-Lekhnath Metropolitan city, Office of Municipal Executive, Newroad Pokhara by hand/courier or through PPMO website www.bolpatra.gov.np on or before **12:00 Noon on 6th Feb-2018 (2074/10/23)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours on 6th Feb-2018 (2074/10/23)** at the office of Pokhara-Lekhnath Metropolitan city, Office of Municipal, Newroad, Pokhara.
8. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting mentioned below, which shall be valid for 30 days beyond the validity period of the bid (i.e 120 days)
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. The PLMC office reserves right to accept or reject any or all bids or annul the bidding process and reject all bids without assigning any reason, whatsoever.
