Bids received after this deadline will be rejected.
7. The bidswill be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours on 6thMarch-2018 (2074/11/22)**at the office of Pokhara-Lekhnath Metropolitan city, Office of Municipal, Newroad, Pokhara.
8. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid,amounting mentioned below, which shall be valid for 30 days beyond the validity period of the bid.(i.e 120 days)
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
