3. Bidding Documents may be purchased electronically for e-submission from e-GP system <http://www.bolpatra.gov.np/egp/> upon payment of a non-refundable fee on or before 20<sup>th</sup> **Nov 2019** and submit their bid electronically.

5. Bids must be submitted electronically on or before *12:00 Noon on 21<sup>st</sup> Nov 2019*. Documents received after this deadline shall not be accepted.
6. Pre-bid meeting shall be held at NLBO at 1:00 PM on 5<sup>th</sup> Nov **2019**.
7. Bids shall be opened in the presence of bidder's representatives who choose to attend *1:00 PM on 21<sup>st</sup> Nov 2019* at the office of *PMC, Pokhara*. Bids must be valid for a period of *90 days* counting from the day of bid opening and must be accompanied by bid security as mentioned above which shall be valid for minimum 30 days beyond the bid validity period i.e. total of 120 days from the day of bid opening.
8. If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in **Deposit Account No.:** 3020303007106 **at Rastriya Banijya Bank, Pokhara** and submit the receipt of the deposited amount of cash along with the bid.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid security validity shall be recognized with effect from the original bid submission deadline.
