1. Pokhara-Lekhnath Metropolitan city, Office of Municipal Executive, Newroad Pokhara invites electronic bids from eligible bidders for the **Supply and Installation of Solar Street Lights** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 60,000,000 (Sixty Millions)**
- Minimum Work experience of similar size and nature: Successful completion of **Minimum single contract which contain minimum installation of 150 solar street Light.**

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

8. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs.1,000,000 (one million)** which shall be valid for 30 days beyond the validity period of the bid (*i.e. 11th July, 2018*)
